Profit after tax in H1 2025 reached VND 5.4 billion, compared to VND 6.4 billion in the same period of 2024. Compared to the same period, H1 2025 saw a decrease of VND 1 billion, equivalent to 16%

- Cost of goods sold (COGS) increased by 191%,
- Gross Profit decreased by VND 1.7 billion equivalent to a 12% decrease compared to the previous year.
- Selling Expenses decreased by VND 0.8 billion compared to the previous year.
- Business operating expenses decreased by VND 0.4 billion compared to the previous year.
- Other Profit increased by VND 0.01 billion compared to the previous year.
